We wish all of you a happy, healthy and prosperous New Year!

I'd also like to welcome Sherry (Hotelling) Brightman as our new Deputy Clerk. Sherry was a Celoron resident for several years, she left the area for 12 years, and has now returned to this area.

Last year the Village finished redoing the boat launch and dock, the amenities building, which will be open in the Spring 2021. The parking lot has been redesigned and newly paved. We also, have a new Lucille Ball Memorial Park sign coming soon. We are still trying to secure funds to construct a new playground. These funds have been difficult to acquire.

It is with regret that I announce the resignation of one of our devoted Trustee's of many years. Norman Mattison has been actively involved in numerous projects, such as the Celoron Rib-Fest, and was instrumental in the planning and execution for various community celebrations. You will be greatly missed.

**<u>CDBG FUNDS</u>**: We are finishing up on the grant we received at the end of 2019. If funds are available for next year we will apply again.

**CURBSIDE GARBAGE & RECYCLABLE COLLECTION:** Enclosed is a copy of the 2021 Curbside Garbage & Recyclable Calendar. We are still not recycling glass because there is no market for it. Glass should be placed in the regular garbage. We will continue to collect plastics twice a month. Please note that no recycling will be collected on March 30<sup>st</sup>, August 31, November 2<sup>nd</sup> and December 7th, 2021.

**WINTER PARKING REGULATIONS:** The Village Highway Department has been busy keeping the streets and sidewalks plowed. Just a friendly reminder: The Village of Celoron does not allow roadside parking between the hours of 2:00 a.m. to 7:00 a.m. from November 1<sup>st</sup> to April 1<sup>st</sup>. The Village of Celoron takes its responsibility of snowplowing seriously and asks that you cooperate with the Village's attempt to serve the entire Village. Therefore, all persons with, or access to, driveways and/or garages are expected to park off the roadways in order to facilitate the required task of snowplowing Celoron's streets. The Village will adhere to the following Winter Parking procedure: A note on the car windshield will be your first and only warning of a violation of the Winter Parking Regulations. A second violation during this winter season could cause, at your expense, your vehicle or anything else parked illegally to be towed. **TOWN OF ELLICOTT & CHAUTAUQUA COUNTY TAX COLLECTION:** The Town of Ellicott **WILL NOT** be collecting taxes in the Celoron Village Hall this year due to COVID-19 concerns.

**CODE ENFORCEMENT:** Code Enforcement Officer, Eric B. Yager. Mr. Yager's winter hours are Mondays from 9:00 am to 4:00 pm. He will resume normal Village Hall hours as of March 29<sup>th</sup>.
